#### Background: Retaining Walls-Beach Road Repairs

#### <u>Development Process - 5 Years</u>

- 2019 Initial Engineering
  - Hire engineering firm, survey site
  - Define the technical requirements for scope and cost estimates
- 2020 Prep and Planning
  - Engage commercial plumbers to clean sewers, inspect (with video cameras) the system, document locations, and report
  - Develop a phased construction plan based on findings (sewer priorities, walls, road, etc.)
- 2020-2021 Construction
  - Drainage project, retaining walls (Upper and Lower)
- 2022 Construction
  - Shotcrete wall with anchors (upper Beach Road)
- 2023 Construction
  - Beach Road resurface project






#### 2022 Project - Shotcrete Wall and Anchors

<u>Upper Section - Illustrative</u>







#### 2023 Beach Road Resurface and Major Repair


- Ideally completed by mid-June 2023
- No major issues / unplanned elements
- **Beneficiary Note** Please completely respect the 2-way traffic signal
  - Critical for crew safety and complex concrete "pours"
  - The hill is "blind" to 1-way travel
  - Remind family, guests, and contractors in Lagoons

#### Financial Recap

- The Trust's cash reserve to manage seasonal cash management for LT/Capital Maintenance is at historic strength.
- There are no *excess reserves*, only timing differences between assessments and actual construction work (permits, contractors, normal delays, seasonal conflicts).
- We will continue to provide periodic updates on the Major
   Capital Maintenance projects as they develop.

#### Legal Update

- Lawsuit filed in July 2020
- Motion to Dismiss filed by the Trustees' Attorney (under D&O insurance policy)
- April 2023 Court Ruling on the Motion to Dismiss Most of Count I was dismissed,
   all of Count II was dismissed
- The sole issue remaining for the Court is "whether the Trustees have breached their fiduciary duties in failing to treat the beneficiaries equally, impartially, and equitably when enacting and enforcing the rules and regulations regarding the use of the Beach and Beach Property."
- Pre-trial Conference for the remaining (partial) Count I is scheduled for July 12<sup>th</sup>
